Why Sponsor Coaching Sessions?

- Projects are the vehicle of strategic change.
 - The increasing rate of change is demanding Speed to Value from those projects.
 - An organization's agility in executing the right change the right way and realising the benefits from those changes.
 - Many IT and project organisations are hampered by bureaucratic and slow project governance and project management models that were first used in the 1980s.
 - The Corporate Executive Board (CEB) *Accelerating Projects* report of 2015 reveals that Sponsor's behaviours have a significant impact on Speed to Value.
 - Most organisations have standards and guidelines on **what** sponsors should do but not **how** to do their roles.

- Seven Consulting can provide a proven transformative approach, not just for how projects are managed, but how projects are governed, sponsored and planned.
 - Project Sponsorship and Project Management are based on collaboration, openness, transparency, simplicity and speed as the levers of change.
 - Seven Consulting has developed a suite of powerful tools and techniques that are proven to assist Sponsors to be more effective and agile.
 - Rob Thomsett has been at the forefront of designing and deploying these methods for over 25 years.

The Sponsor ensures the strategic impact and benefits of the project are aligned with the organisation's strategic and financial goals. The Sponsor determines the goal or outcome of the project and owns his or her project through the entire project life-cycle – planning, development, on-going operations and benefit realisation. The Sponsor must also be the key advocate for their project supporting their PM and team.

There are five major Governance functions undertaken by a Sponsor. These functions should be undertaken in an open and transparent partnership between the Sponsor, Program Manager and critical stakeholders.

These are:

Leading the development and approval of project Business Case

- Identification of expected Program Outcome and related benefits;
- Engagement of critical stakeholders;
- Proactive mitigation of project risks; etc.

Determining and managing the overall Project Governance process

- Agreement on project status reporting cadence;
- Composition and chairing of the Steering Committee;
- Oversight of Organisational Change Management impact; etc.

Monitoring the on-going status of the project and Business Case;

- Regular meetings with the Program Manager;
- Participation in key project reviews and retrospectives;
- Regular updates to colleagues and peers, etc.

Assistance in and approval of project change

- Assistance in resolution of project issues;
- Assessing impact on Business Case of changes;
- Agreement with and approval of updated Business Case and related plans; etc.

Oversight of on-going operations and benefit realisation

- Oversight of the Change Management implementation;
- Ensuring relevant resources and processes are funded and operational;
- Ensuring that planned benefits are realised in partnership with Benefit Owners; etc .



Sponsor Coaching topics are explored in a 4-hour session with two sections. Each session also 1 hour of pre and post-session reviews. To enhance open conversations, engagement and understanding of critical concepts, it is recommended that no more than 10 executives attend each session.

Section 1: Setting up projects for success

Leading the development and approval of project Business Case

- This tutorial covers the roles, accountabilities and behaviours of sponsors and, importantly, the various project contracts and tool required by senior management for governing their projects - Business Case, Success Definition, Benefits Realisation, Project Risk, etc.

Key tools for Sponsors

- This tutorial explores tools that have been proven to assist sponsors in clarifying and defining their critical expectations for their project, to more effectively engage stakeholders and create an open and collaborative approach to project & benefits planning.

Determining and managing the overall Project Governance process

- This tutorial examines agreement on project status reporting structure and content; engagement and management of stakeholders/related projects, Steering Committee charters and composition.

Section 2: Ensuring and measuring success

Monitoring the on-going status of the project and Business Case;

- The critical issues of project tracking and reporting cadence and relationship to project delivery risk are introduced, In addition, the tutorial considers the critical project/program data or metrics that provide sponsors with open and transparent information. The value of Health Checks, retrospectives and warning signs for projects under challenge.

Assistance in and approval of project change

- This tutorial explores the critical role of sponsors in assisting project managers in dealing with project change, resolution of issues and alterations to the approved Business Case. This tutorial also considers 10 key questions that sponsors must be aware of to assess project change.

Oversight of on-going operations and benefit realisation

- This tutorial overviews the key Change Management planning and implementation actions required by sponsors, the planning and management of on-going operational support and Benefits Realisation and ultimate project closure.

Sponsor Coaching – Key Focus

While most organisations have existing guidelines and frameworks that describe **what** the sponsor role is and **what** sponsors are accountable for these guidelines and frameworks typically provide little or no detail on **how** the sponsor undertakes this critical role and tools and concepts to assist the sponsor in effectively achieving success.

The essential need for an open and collaborative partnership between sponsors, their project managers and stakeholders is a key focus of Seven Consulting's Sponsor Coaching sessions.

The Sponsor Coaching sessions explore key roles for sponsors such as setting up a project for success by the sponsor actively engaging with project managers and critical stakeholders, especially during the initial planning steps with a focus on expected outcome and related benefits. This requires a shared understanding amongst all groups in areas such as benefits, project risks, decision-rights, governance cadence and project change control.

Seven Consulting has developed a unique set of tools and concepts that have successfully assisted sponsors in fully owning and governing their projects and benefits realisation. These tools and concepts are described in Seven Consulting's *The Sponsor Guide* booklet and are a core focus of Sponsor Coaching sessions.
